Price list of services provided on the object of the service infrastructure of the railroad siding managed by CLIP TERMINALS Sp. z.o.o.

- 1. Legal basis for determining a method of setting charges for services provided by the Operator to the Operator for the Carrier within the framework of OIU access is stipulated in the article 36e of the Railway Act.
- 2. The price list is valid from 01.01.2024
- 3. The basic charge is collected for services provided by the Operator to the Carrier. Carrier, i.e. for access to cargo terminals specified in Chapter II, item 7 Regulations.
- 4. An additional fee is charged for ancillary services performed as part of access to commodity terminals as defined in Chapter II, Section 7 of the Regulations.
- 5. Definitions of the terms used in the Price List to the OIU

**Access to Service Facilities** - a fixed fee for the entry of the depot into the CLIP siding area and the introduction of the depot to the loading points at designated terminals.

**8-hour loading slot** - fee for loading point track occupancy in a designated slot calculated per rail vehicle. Applies to Terminals I and IV

**8-hour loading slot** - fee for loading point track occupancy in a designated slot calculated per rail vehicle. Applies to Terminals II and III

**The service of unloading a vehicle placed backwards on the ramp** - Unloading of vehicles loaded on wagons contrary to the recipient's instructions









**Additional work of the locomotive on the basis of a separate order** - lending a locomotive with a shunting team

Siding track occupation - CLIP siding track occupation outside a designated loading slot

**Traction charge** - fee paid by the carrier for placing a train on CLIP siding with the use of electric or diesel traction

**Traction service** - fee for using CLIP locomotive together with shunting team for putting in/out a train of another carrier from/to Swarzędz station, including the fee for Access to Service Facilities
