2. We provide a **60-month warranty** for the entire subject of the contract, starting from the date the Ordering Party signs the defect-free Final Acceptance Protocol for the subject of the contract. The warranty period is always equal to the period of the granted warranty.
3. We will complete the entire order on time, **until October 31, 2026, provided that:**
 - a) **by April 29, 2026**, we will prepare and submit to the Ordering Party the complete construction documentation of the Investment,
 - b) **by July 31, 2026**, we will complete construction works, delivery and comprehensive assembly of all elements of the electricity storage system,
 - c) **by August 31, 2026**, we will install, configure and integrate the functional elements of the electricity storage system.
4. We declare that we have read the Request for Proposal and its attachments and have no reservations thereto, and have received the information necessary to prepare the offer.
5. We declare that we consider ourselves bound by this offer for the period indicated in the Request for Quotation.
6. We declare that the subject of the order offered by us will be consistent with the specifications indicated in the Request for Quotation, including in particular the Terms of Reference, which constitute annexes to this offer.
7. We declare that we will perform the subject of the order in accordance with the principles of modern technical knowledge, standards and applicable regulations as well as the provisions of the Agreement concluded with the Ordering Party.
8. We declare that all documents and statements submitted with the offer are true.
