**STATEMENT**

By joining the procurement procedure for **"Construction of the BESS-H7 electrical energy storage system with a maximum charging and discharging power of 2.0 MW and a nominal capacity of 5.15 MWh"** I declare on behalf of the Contractor that there are no circumstances that would exclude me from applying for the contract, in particular:

- I have not been declared bankrupt and no liquidation proceedings have been opened against me,
- I am not linked to the Ordering Party personally or by capital, where capital or personal links are understood as mutual links between the Ordering Party or persons authorized to incur obligations on behalf of the Ordering Party or persons performing on behalf of the Ordering Party activities related to the preparation and conduct of the procedure for selecting the Contractor and the Contractor, consisting in particular in:
  - a. participating in a company as a partner in a civil partnership or partnership,
  - b. owning at least 10% of shares or stocks (unless a lower threshold is provided for by law),
  - c. performing the function of a member of the supervisory or management body, proxy, or attorney,
  - d. being in a marital relationship, a relationship of kinship or affinity in a direct line, a relationship of kinship or affinity in the collateral line up to the second degree, or being related by adoption,

- care or guardianship, or being in cohabitation with the contractor, his legal representative or members of the management or supervisory bodies of the contractors applying for the contract,
- e. being in such a legal or factual relationship with the contractor that there is a justified doubt as to their impartiality or independence in connection with the contract award procedure.
- I am not subject to exclusion from the proceedings under Article 7 paragraph 1 of the Act of April 13, 2022, on special solutions for counteracting support for aggression against Ukraine and for protecting national security (Journal of Laws of 2022, item 835, as amended)<sup>1</sup>.
